PET GUIDELINES AND INFORMATION

As per the Tenancy Agreement:

- Only pets for which the tenant has written approval/permission will be allowed.
- The Landlord reserves the right to revoke permission to keep a pet.
- Only two pets will be allowed per unit, unless otherwise specified.
- Pets must be contained within the tenant's property. Clotheslines, trees, gas pipes, door handles, etc. are not proper restraints.
- AT NO TIME ARE PETS ALLOWED TO RUN AT LARGE.
- The yard or area where your pet is kept must be cleaned frequently (at least once a week).
- Vacating tenants may be subject to being assessed a charge for yard cleaning.
- Excessive noises/disturbances created by pets will not be tolerated.
- The Animal Control Office (ACO) 239-1359 may be called when guidelines are not followed.
- All dogs (3 months-of-age and older) MUST BE LICENSED WITH THE R.M. OF PORTAGE LA PRAIRIE and proof of licencing provided to Southport Aerospace Centre Inc.
- Pets should receive annual rabies vaccinations the first shot MUST be at 6 months-of-age. Proof of the
 rabies vaccination (from a licensed veterinary doctor) must be provided to the Southport Property Management Department, before permission to keep the animal is granted.
- Pets CANNOT be changed without requesting permission in writing.
- Owners are responsible for all fines/costs incurred should their pet be impounded.
